



INTRODUCTION

BACKGROUND

Definition of disability

As defined by the World Health Organization Disability "is an umbrella term, covering impairments, activity limitations, and participation restrictions. Impairment is a problem in body function or structure; an activity limitation is a difficulty encountered by an individual in executing a task or action; while a participation restriction is a problem experienced by an individual in involvement in life situations. Thus disability is a complex phenomenon, reflecting an interaction between features of a person's body and features of the society in which he or she lives."

The Convention on the Rights of Persons with Disabilities (2006), the first legally binding disability specific human rights convention, adopted by the United Nations gives two descriptions of disability. The Preamble to the Convention states that "Disability results from the interaction between persons with impairments, attitudinal and environmental barriers that hinder their full and effective participation in society on an equal basis with others." Again it emphasizes that "Persons with disabilities include those who have long term physical, mental, intellectual or sensory impairments which in interaction with various barriers may hinder their full and effective participation in society on an equal basis with others." Both the expressions reflect a shift from a medical model to social model of disability.

Rights of Persons with Disabilities Act 2016 abides by the CRPD definition.

Overview of the population with disability

Persons with disabilities constitute a huge and heterogenous population. Though Census 2011 pegs it as twelve lakhs and forty four thousand in Odisha, considering the underneath facts, there are a minimum of 70-80 lakhs people in Odisha with a disability.

- 1. RPwD Act in 2016 increased the number of categories from 7 to 21.
- 2. World Report on Disability 2015, by WHO, pegs the population as 15% of total population of a country/state/village.
- 3. This is 2021, a decadal growth of population has happened since 2011.

Persons with disabilities are not a homogeneous group; they have different capacities and needs, require different types of assistance or no assistance, and contribute in different ways to their communities. One cannot really speak of them as a group in a meaningful way, except perhaps with respect to the rights that all are accorded under the CRPD guided RPwD Act 2016. Tremendous diversity characterizes the population. The progression of only a few degrees from the eyes to the ears, the ears to the mouth, the hand to the legs, or the mental faculty brings to the more completely different functional challenges, and thus, necessitates completely different accommodation and support system.

Why PwD Act 1995 did not have universal applicability in Odisha?

The best chance of successful use of the law by people is, if everybody is aware of them.

The 1995 PWD Act wasn't widely publicised. It neither has reached the nook and corner of Odisha in the 20 years of its existence, nor has been translated into the various alternate formats and circulated widely. The endeavour of the Persons with Disabilities (Equal opportunities, Protection of Rights and Full Participation) Act 1995 was to introduce an instrument for promoting equality and participation of persons with disability on the one hand, and eliminating discriminations of all kinds, on the other. The Act covered seven disabilities. The Act spelt out responsibilities of the Government at all levels including establishments under its control. Furthermore, the institution of Chief Commissioner in the Centre and Commissioner for Persons with Disabilities in States was done. Their mandate was to redress individual grievances, provide safeguards to the rights of persons with disabilities, monitor implementation of disability related laws, rules and regulations, and oversee utilisation of budget allocated on disability. These quasi-judicial bodies were vested with the powers of a civil court.

However, it was used by a handful of people, only in urban areas, as awareness about the law was abysmally low.

SCOPE

CRPD 2006

Article 8 of the UNCRPD

1. States Parties undertake to adopt immediate, effective and appropriate measures:

- a. To raise awareness throughout society, including at the family level, regarding persons with disabilities, and to foster respect for the rights and dignity of persons with disabilities;
- b. To combat stereotypes, prejudices and harmful practices relating to persons with disabilities, including those based on sex and age, in all areas of life;
- c. To promote awareness of the capabilities and contributions of persons with disabilities.

2. Measures to this end include:

- a. Initiating and maintaining effective public awareness campaigns designed:
 - i. To nurture receptiveness to the rights of persons with disabilities;
 - ii. To promote positive perceptions and greater social awareness towards persons with disabilities;
 - iii. To promote recognition of the skills, merits and abilities of persons with disabilities, and of their contributions to the workplace and the labour market;
- b. Fostering at all levels of the education system, including in all children from an early age, an attitude of respect for the rights of persons with disabilities;
- c. Encouraging all organs of the media to portray persons with disabilities in a manner consistent with the purpose of the present Convention;
- d. Promoting awareness-training programmes regarding persons with disabilities and the rights of persons with disabilities.

Rights of Person with Disabilities Act 2016 (RPwD)

RPwD Act Highlights

The most important statuette in RPwD Act 2016 is that the number of recognized disability conditions has been increased from 7 to 21. The new list of recognized disabilities includes three blood disorders (Thalassemia, Hemophilia and Sickle Cell disease). Acid attack survivors have also been included in the list. Intellectual disability, Parkinson's disease, Cerebral Palsy, Dwarfism and Autistic Spectrum disorders also find place in the list. This inclusion will help more people to have access to the Government schemes and facilities intended for the welfare of disabled people in India.

The RPwD Act 2016 also provides for creating institutional infrastructure to support the needs of persons with disabilities. Setting up of Special Courts in each district has been mandated. These courts will handle the cases related to the violation of rights of disabled people. In addition, State Governments will setup district-level committees and a separate State Fund for the welfare of PwDs. Similarly, a national level fund will also be set up.

For children with disabilities aged between 6 and 18 years; education will be free.

In an attempt to eliminate discrimination, punishment by imprisonment has been mandated for those who intentionally insults or intimidates with intent to humiliate a person with a disability in any place within public view.

Chapter VIII, Section 39 elaborates awareness campaigns.

- 1. The appropriate Government, in consultation with the Chief Commissioner or the State Commissioner, as the case may be, shall conduct, encourage, support or promote awareness campaigns and sensitisation programmes to ensure that the rights of the persons with disabilities provided under this Act are protected.
- 2. The programmes and campaigns specified under sub-section (1) shall also,
 - a. Promote values of inclusion, tolerance, empathy and respect for diversity;
 - b. Advance recognition of the skills, merits and abilities of persons with disabilities and of their contributions to the workforce, labour market and professional fee;
 - c. Foster respect for the decisions made by persons with disabilities on all matters related to family life, relationships, bearing and raising children;
 - d. Provide orientation and sensitisation at the School, College, University and professional training level on the human condition of disability and the rights of persons with disabilities;
 - e. Provide orientation and sensitisation on disabling conditions and rights of persons with disabilities to employers, administrators and co-workers;
 - f. Ensure that the rights of persons with disabilities are included in the curriculum in Universities, Colleges and Schools.

Public awareness and understanding of disability rights

The landmark human rights law in India, Rights of Persons with Disabilities Act 2016, calls for the transformation of society in order to ensure the inclusion of persons with disabilities and their participation on an equal basis with others in all aspects of life. Awareness-raising, access to information and freedom of expression play key roles in this transformative process to remove barriers, particularly those created by stereotypes and negative attitudes embedded obstinately within our cultures and communities.

Busting myths about disability was the core of the awareness campaign by focusing on facts. The campaign debunked some of the most common myths on disability and persons with disabilities:

MYTH: There aren't many people with disabilities, so it's not really an issue.

FACT: People with disabilities are present in all societies. Many are hidden or excluded from society, either in their homes or in institutions because of social stigma. There may be barriers – physical, attitudinal, legal, regulatory, policy, lack of information in accessible formats – that limit their opportunity to participate in a variety of activities. Furthermore, a disability may not be visible. Some people who have a disability may not even think of themselves as "disabled".

MYTH: Disability is a health issue.

FACT: (The adoption of the UNCRPD marked the international agreement to shift from a "medical model" to a "social one".) Health is important for everyone – whether [one has disabilities] or not. But health is not the only, or in some cases, most important issue. For many people with disabilities, participation in work, education, politics, among other spheres of life, is equally important.

MYTH: Persons with disabilities are unable to meet performance standards, thereby making them an employment risk.

FACT: Employers of workers [with disabilities] consistently report that, as a group, people with disabilities perform on par or better than their peers [without disabilities] on measures such as productivity, safety and attendance. In addition, people with disabilities are more likely to stay on the job.

MYTH: Accessibility only benefits people with disabilities.

FACT: Good accessibility benefits everyone. Accessibility is strongly linked to the design of products, devices, services or environments and takes into consideration everyone's needs – whether or not they have a disability.

MYTH: Considerable expense is necessary to make workplace adjustments for workers with disabilities.

FACT: Making reasonable adjustments in the workplace refers to measures or actions taken by employers to help [persons with disabilities] work or to take part in training on the same basis as individuals [without disabilities]. Most workers with disabilities require no special adjustments and the cost for those who do is minimal or much lower than many employers believe.

OSdN conducted the Campaign?

OSdN (Odisha state Disability Network) was founded in 2003 with the notion that - On their own no one can change very much, but by coming together disabled people can have a stronger voice. Campaigning together disabled people can raise awareness, change attitudes, change laws. OSdN is a conglomeration of about 35 NGOs and over 50 individuals with disabilities from across the state. It has regional and district structures. The members come together to raise "United Voices" for achieving various goals.

A History of Successful Campaign by OSdN

Established in the year 2003, Odisha State Disability Network (OSdN) with its regional and district level structures, has been instrumental in conceptualising the "Single Window Approach" and conduct in Rourkela in 2003, for ease of accessing entitlements at Rourkela which later on became the "Bhima Bhoi Scheme" of the Government. OSdN facilitated the 1st Political convention in 2004-2014 for inclusion of disability issues in respective party manifestos. It initiated CBR intervention in 2004, appointment of independent Disability Commissioner - 2010, designation of Minister as "Minister Disability," formation of the "Disability Directorate" and establishment of separate department for disability i.e. SSEPD 2014-15. The network conducted a successful "Census Campaign" in 2011 leading to Odisha having higher disability percentage (2.9%) as compared to national average of (2.21%).



Sashakt Doot

The Sashakt Doot is an awareness vehicle which was flagged off on 9 May 2018 at Puri and covered 4,100 km across the 30 districts of the state. This campaign included conducting public meetings in 55 blocks and 30 district headquarters, meeting with over 50,000 people. The Sashakt Doot reached Bhubaneswar on 13 June 2018.





AWARENESS DRIVE ON DISABILITY FROM PURI Steps to ensure equality

Bhubaneswar: A state-wide campaign to create awareness on the disability issues and the Rights of Persons with Disabilities Act, 2016, will be launched from Wednesday.

The campaign, Sashakt, will be flagged off from Puri and conclude at Nayagarh on June 13. It aims to promote awareness and inclusion of people with disabilities, knowledge about laws, existing government facilities to society by the Odisha State Disability Network.

Disability activist Sruti Mohapatra, who is spearheading the campaign, said: "All residents of Odisha have a lot to offer our society, including those with disabilities, who are often left behind. During the campaign we will focus on inclusion and help everyone in our state live more self-determined and independent lives."

"We have planned to reach one million people by November. An awareness rath, along with a mobile photo exhibition, will move along with the campaign team all across the state," Mohapatra said.

There will be five mass awareness programmes in a day during the campaign in each area discussing, analysing and understanding the law, roles and responsibilities. The campaign song, logo, website, T-shirt, caps, disability posters and badges were launched on Monday.


Puri is a coastal district on the eastern part of Odisha, India. It derives its name from the heritage city of Puri, abode of Lord Jagannath, and one of the four pilgrimage centres of India.






JAJPUR 17 May 2018




KEONJHAR






DEOGARH









ANGUL






SUBARNAPUR



with disabilities face overt discrimination, stereotyping, and lack of respect for their basic human rights. We all must find new approaches and tools to work for and with the people with disabilities. These should include mainstreaming disability in regular daily life and development strategies, engaging and empowering people with disabilities, and the organizations that represent them". Suresh Choudhury (ex. sarpanch and a PwD) said, "Article 29 of the Convention on the Rights of Persons with Disabilities (UNCRPD) clearly states the rights of persons with disabilities to participate in political and public life without discrimination and on an equal basis with others, and it calls upon state parties to guarantee those rights. Article 326 of the Constitution of India provides for the 'Right to be Elected' under the 'Right to Adult Suffrage'. However, the Indian Government has not introduced any provisions yet to ensure equal representation in the Parliament, State Assemblies and Panchayats in the country for the disabled community."




NABARANGPUR

Then felicitations of the Pala Team from Jagatsinghpur lead by Abhimanyu Nayak followed by their performance. Next Pala Team from Sundergarh presented their theme on RPwD Act 2016 led by Manabodha Padhan. After the lunch session our Sashakt Team performed a Campaign song followed by Dasakathia by the Bhadrak Team led by Sudam Chandra Sahu.

Rati Mishra, coordinator NCPEDP, Delhi thanked OSdN and Swabhiman for the honor and welcomed the idea and initiative taken by Swabhiman in particular. Sri Srinivasalu, NDN Partner, Andhra Pradesh and Telengana, said this Campaign is a model and example for the nation. After felicitation of the Pala Groups by Honorable Union Cabinet Minister, Dharmendra Pradhan the Toll Free No was inaugurated by Guruji H. H. Paramahamsa Prajnanananda ji Maharaj. It will be used for giving information on RPwD Act 2016 and other related matters until 2019.

Honorable Union Cabinet Minister, Dharmendra Pradhan said, disability is not man made instead it happens accidentally or due to birth related complications. He promised to provide employment opportunities to 1000 PwDs through a skill program.

Guruji H. H. Paramahamsa Prajnananandaji Maharaj said, all who are working as public servants should come down from their chair to understand the needs of the people. The administration has not changed since the British Rule as the policy is continued by the people of our country. So a change in attitude is required to understand the need for PwDs to develop a civil society with equal opportunity. In each session 10 district partners and DSSOs were felicitated by OSdN, facilitated by Swabhiman.

At the end of the meeting Jyoti Prasanna Pattanaik, Joint Coordinator, Sashakt Campaign gave vote of thanks to all the guests, participants, sponsors and district partners for making it a grand success. Total of 822 people from all the 30 districts, NGOs and Government functionaries participated in the valedictory ceremony.

The Way Forward was presented by Dr. Sruti Mohapatra. She said "Disability is part of the human condition. Almost everyone will be temporarily or permanently impaired at some point in life, and those who survive to old age will experience increasing difficulties in functioning. Disability is complex and the interventions required to overcome disability disadvantage are multiple, systemic, and will vary depending on context. However, one toll which will be needed for another ten years is "Awareness Raising". People are generally not against equal rights for persons with disabilities, but they do not necessarily see the benefits either. Hence, campaigns like SASHAKT are necessary to highlight barriers, prejudices and ignorance that persons with disabilities experience on a daily basis; the economics of disability inclusion, measures which would enable persons with disabilities to live independently, build a network, spend their leisure time to learn, get a job and feel useful, and to have a feeling of self-worth, self-realisation and self-determination. Additionally, strong reciprocal partnerships are needed to achieve goals of equal rights for persons with disabilities. There is not one model which will work everywhere, but some elements of successful models are transferable.

The main message of SASHAKT is to start from common denominators, rather than differences or implementation problems. SASHAKT uses the energy of the people and organisations/institutions affected when enabling the rights of persons with disabilities. Involving persons with disabilities in strategies is not enough. When it comes to the rights of persons with disabilities to mainstream jobs, employers from industry and services and their representatives should also be involved in the co-creation of strategies. When it comes to the right to independent living, current institutions and service providers should also be involved, no matter how long it takes. One could argue that if they are part of the problem, they should also be part of the solution. When it comes to the right to education, mainstream and special school boards - where relevant - need to be there when creating strategies for change. Making persons with disabilities part of mainstream activities is the best choice to enable their rights. To get there, working with all stakeholders on sustainable solutions.

WAY FORWARD

Disability is part of the human condition. Almost everyone will be temporarily or permanently impaired at some point in life, and those who survive to old age will experience increasing difficulties in functioning. Disability is complex and the interventions required to overcome disability disadvantage are multiple, systemic, and will vary depending on context. The SASHAKT CAMPAIGN aligned with the principles of United Nations Convention on the Rights of Persons with Disabilities (CRPD), adopted in 2006, which aims to "promote, protect and ensure the full and equal enjoyment of all human rights and fundamental freedoms by all persons with disabilities, and to promote respect for their inherent dignity" is an effort at taking the "Rights of Persons with Disabilities Act 2016" to people living in even the remotest village of Odisha.

The aim of SASHAKT Campaign is to create a "Buzz on Disability, Diversity and Inclusion in Odisha," while making the major shift in global understanding and responses towards disability reach the last person in the last village of Odisha. It is a campaign to promote greater awareness and inclusion of people with disabilities, knowledge about the laws, existing government facilities to society by Odisha State disAbility Network (OSdN). In the initial phase we covered all the 30 district headquarters. In the future activities of Sashakt Campaign we will continue OSdN's legacy of building bridges of inclusion. The Sashakt campaign designed to create an Equal India, an Inclusive India and an India where differences are accepted and diversity celebrated, will continue doing so in future activities. In the first phase we raised awareness throughout society, including at the family level, regarding persons with disabilities, respecting their rights and dignity; combating stereotypes, prejudices and harmful practices relating to persons with disabilities; and the capabilities and contributions of persons with disabilities. In the second phase our focus will be on covering block headquarters. In the third phase we have planned to join BBSA camps and in villages in the last phase. Reaching the last person of the last village is the priority with which we are working. In the initial phase we got success in addressing the RPwD Act 2016 at collectorate level and line departments, connected with different agencies who are working in the disability sector.

But spreading the message further and strengthening the network is also important for us now. So we are looking forward to connecting with DPOs (Disabled People's Organization), networks and mainstream NGOs. Through BBSA camps we are planning to identify more PwDs through spot verification and medical assessments. At block level we are planning organizing meetings with BSSOs, BEOs, local villages and agencies. There is an attitudinal barrier and breaking this scenario by bridging the gap between the disabled and non disabled is what we are looking for. Like the initial phase we will organize public meetings, Audio-visual show, Photo exhibition, Street play, Distribution of leaflets and posters on RPwD Act 2016. Wall painting on rights of PwDs, boards on "Know Your Rights", Talent show by PwDs, Press meets, Community Radio Programs and clarifying gueries through Toll free number. Further by using the social media we plan showcasing individuals with extraordinary achievements. Articles in Print and Electronic Media, Website Posts, Promoting Blog Writers, Posts in Facebook, Instagram and Twitter, Distribution of posters, flyers, bookmarks, books and sand art are the medium we will use to reach our target. To reach 10,00,000 people and make them understand about inclusion which is important for us. Organizing more street plays and using folk medium will help our cause to spread the message amongst illiterates at grass root level. To make the line departments aware we will publish articles in the media to sensitize the government. officials. We will create 3000 engaged community change makers at village levels so that, it will help in generating applications of demand for entitlements. It is not an easy task to carry out such a mass awareness campaign but together we can progress with collaboration. It was possible because of the joint effort made by OSdN, a combination of more than 35 NGOs and 50 individuals who are the backbone of this campaign. And it was possible in the first phase because of the commitments and determination shown by OSdN partners which motivated us to move forward despite various difficulties.

SASHAKT campaign, on the basis of its pan Odisha travel, suggests that many of the barriers people with disabilities face are avoidable and the disadvantages associated with disability can be overcome. Inclusion and sustainable development requires involving different sectors – health, education, social protection, labour, transport, housing – and different actors – governments, civil society organizations (including disabled people's organizations), professionals, the private sector, and people with disabilities and their families.

Recommendation 1: Enable access to all mainstream policies, systems and services

People with disabilities have ordinary needs – for health and well-being, for economic and social security, to learn and develop skills, and to live in their communities. These needs can and should be met in mainstream programmes and services. Mainstreaming not only fulfils the human rights of persons with disabilities, it is also more effective. Mainstreaming is the process by which Governments and other stakeholders ensure that persons with disabilities participate equally with others in any activity and service intended for the general public, such as education, health, employment, and social services. Barriers to participation need to be identified and removed, possibly requiring changes to laws, policies, institutions, and environments.

Recommendation 2: Adopt a state disability policy and plan of action The development, implementation, and monitoring of a state policy should bring together a broad range of stakeholders including relevant government ministries, non-governmental organizations, professional groups, disabled people and their representative organizations, the general public, and the private sector. The strategy and action plan should be informed by a situation analysis, taking into account such factors as the prevalence of disability, needs for services, social and economic status, effectiveness and gaps in current services, and environmental and social barriers. The strategy should establish priorities and have measurable outcomes. The plan of action operationalizes the strategy in short and medium terms by laying out concrete actions and timelines for implementation, defining targets, assigning responsible agencies, planning and allocating needed resources. Mechanisms are needed to make it clear where the responsibility lies for coordination, decision-making, regular monitoring and reporting, and control of resources.

Recommendation 3: Involve people with disabilities People with disabilities often have unique insights about their disability and their situation. In formulating and implementing policies, laws, and services, people with disabilities should be consulted and actively involved. Disabled people's organizations may need capacity-building and support to empower people with disabilities and to advocate for their needs. When suitably developed and funded, they can also play a role in service delivery – for example, in information provision, peer support, and independent living.

Recommendation 4: Improve disability data collection

Data need to be disagreegated by population features, such as age, sex, race, and socioeconomic status, to uncover patterns, trends, and information about subgroups of persons with disabilities.

Recommendation 5: Strengthen and support research on disability

Research is essential for increasing public understanding about disability issues, informing disability policy and programmes, and efficiently allocating resources.

Translating recommendations into action

To implement the recommendations, strong commitment and actions are required from a broad range of stakeholders. While National Governments have the most significant role, other players also have important roles. The following highlights some of the actions that the various stakeholders can take.

Odisha Government can:

- Review and revise compliance and enforcement mechanisms.
- Review mainstream and disability-specific policies, systems, and services to identify gaps and barriers and to plan actions to overcome them.
- Develop a state policy and action plan, establishing clear lines of responsibility and mechanisms for coordination, monitoring and reporting across sectors. Allocate adequate resources for the same.
- Regulate service provision by introducing service standards and by monitoring and enforcing compliance.
- Introduce measures to ensure that people with disabilities are protected from poverty and benefit adequately from mainstream poverty alleviation programmes.

Disabled peoples organizations can:

- Support people with disabilities to become aware of their rights, to live independently, and to develop their skills.
- Support children with disabilities and their families to ensure inclusion in education.
- Represent the views of their constituency to local decisionmakers and service providers, and advocate for their rights.
- Contribute to the evaluation and monitoring of services, and collaborate with researchers to support applied research which can contribute to service development.
- Promote public awareness and understanding by professionals about the rights of persons with disabilities – for example, through campaigning, advocacy, and disabilityequality training.
- Conduct audits of environments, transport, and other systems and services to promote barrier removal.





Dr. Sruti Mohapatra Chairperson

Dr. Sruti Mohapatra spurned a career in Indian Civil Services to become a leading crusader for disability rights. Meeting an accident at the age of 22 that left her paralysed from neck below, but, she has not given up on life. By 2009, she had trained over 300 civil non-disabled service aspirants who made it to top Government as well as Private Sector jobs. Now she is training students with disabilities.

Amid the anger of rejection and humiliation, she had joined DPI, started Swabhiman, an organisation that has been working towards empowering persons with disabilities. Her efforts have resulted in many positive changes in Odisha and India, which include policy changes, new laws. She has been instrumental in increasing public awareness on the issue of disability and has been working towards accessible cities. She started a project called Anjali that has initiated an inclusive society. This festival has brought together around 49,000 children (disabled and non-disabled) and 10,000 youth to live together for 5 days so that through interaction they will understand each other and appreciate each others' qualities and capabilities, and, thereby, create an inclusive society. Over a 1000 youths have got scholarships and employment.

She has conceptualised Saksham, Sashakt, YLTEP, Swabalamban, Ekta and many such empowering programs for the disabled in India. She has own over 75 awards. She is often invited to give motivational speeches at various institutions and corporate houses.



Mihir Mohanty Director & Chief Coordinator

Mihir Mohanty is the Director of Programs in Swabhiman. As Chief Coordinator of Sashakt Campaign he provides backbone strength to the whole awareness drive. He provided the sketch map by collaborating with OSdN partners to undertake the campaign at the district level. He has over two decades of experience in the social development sector credit both at national and international NGOs such as Action Aid Internatioal, Save the Children, UK, UNWFP, Side-Et-Action, BvLF, Natherland and PACS Program under DFID.

In his 22 years of work experience, he has been engaged in rehabilitation projects such as cyclone flood, tsunami, earthquake and communal riots. His master degree in Psychology with specialisation in "Educational Psychology" has helped him to work efficiently in education sector, livelihood and food security, etc. His wide range of experience from the level of gram panchayat coordinator to the project manager at national and international level has enabled him to efficiently manage Sashakt Campaign.






