Introduction

A long journey from 1996 to till 2010 in the state of Orissa. 10.21 lakh people with disability were yet to have a disability commission and full time disability commissioner to hear the injustices they suffer, to lend a ear to their grievances and to alleviate their sufferings. Many battles had been fought by different organizations, individuals and networks for the above cause but either they could not reach the center of power or when they did mere wordy assurances were given. But this time

From 21 district more than 220 persons with disability, their family members and organizations, assembled in VRC under the dynamic leadership of Dr. Sruti Mohapatra, Chief Executive of Swabhiman and convener of Orissa State Disability Network (OSDN), which saw the formation of a Independent Disability Commission with a full time Disability Commissioner in Orissa on 27th of March 2010.

As per the PWD (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 the government mandates appointment of a disability commissioner (Clause 60, section (1) states - Every State Government may, by notification appoint a Commissioner for persons with disabilities for the purpose of this Act.) But despite 15 years having passed government was turning deaf ears to all petitions, appeals, memorandum and rallies. And then all PWDs and organizations came together and UNITED THEY WON!

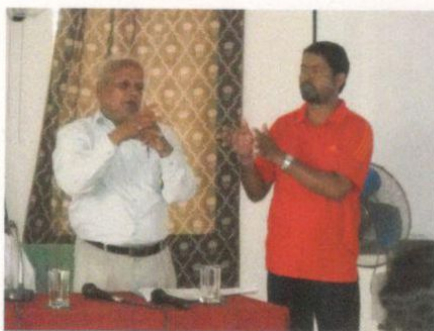
Letter Sent by SWABHIMAN to NGOS
It has been a long journey from 1996, since the PWD Act was passed by Parliament in 1995. It mandated the establishment of DISABILITY COMMISSION and yet to have the basic mechanism in place to address our needs. Neither is the government sensitive to our issues nor does it listen to our demands.
18 states in India have Independent DISABILITY COMMISSIONERS.
Our appeals have fallen to deaf ears. Let us come together, cutting across disabilities, districts and organizations. More than 100 participants (persons with disabilities) from across Orissa will converge to discuss and debate to present a memorandum to the state government for the IMMEDIATE FORMATION OF A DISABILITY COMMISSION in Orissa.

A team consisting of P.K.Mishra (parent), Sudipta Mishra (CP), Sannyasi Behera (VI), Satyanarayan Mishra (OH), M.M.Prusty (parent), Mr. Prusty (MR), Reeta Jena (Parent - Autism), Sruti Mohapatra (OH) and Asit Behera (Swabhiman staff) met both the Chief minister and the leader of opposition and handed over the memorandum. Leader of opposition was well apprised of and he assured to raise the issue on the floors of the Assembly and the CM agreed to appoint the commissioner for disabled immediately the issue on the floors of the Assembly and the Chief Minister assured of a commission soon. A 11 member delegation met the Chief Minister on 6th March 2010 at 6 pm at Secretariat for a final round of discussion.



Brief of 21st Meeting - Except from Deliberations



Sri. Bijay Kumar Parida, General Secretary OAD, his fingers talking for him, lamented how the PWDs in Orissa have been marginalized, subjugated and under the strong grip of an inferiority feeling as they are treated like second class citizen in their own state. Despite of their ability and knowledge PWDs, especially deaf youth are not getting jobs. He stressed on the rigors PWDs face to enter secretariat and meet the WCD secretary or go to WCD department for their problems.

Sri Madhabananda Ray, General Secretary of AOOHWA, highlighted the efforts made by him and various organizations in getting a commission set up in Orissa. He lamented on the apathetic attitude of government towards the issues of persons with disabilities.



Mr. Sannyasi Behera, General Secretary of OAB, was aggrieved by the deafness and callousness in the rape case of a visually challenged girl. Hardly had she been able to grab the attention of government that the same incident was reported as the cause of death of a four year disabled girl in Dhenkanal, on the eve of world disability day, in the year 2009.



Sri Umesh Phurohit, active member of OVM, and representative of ODPN, said our campaign is not only till the appointment of the disability commissioner but it will continue for long. Therefore we need to build alliance between the organizations, associations, networks by forgetting everything else. He gave many examples of the efforts made by OVM and others for the formation of the commission.





K. Anand Roy described how OVM tried to draw the attention of the government by repeated 'post card abhiyan' in the last 3-4 years. He also elaborated how the callous government did not send a representative to receive their memorandum on 3rd December 2009. Although a rally of 1000 PWDs came to the state capital on that day, no ministers or secretary deemed it fit to listen to the rallying party.

Sri Umesh Nayak, General Secretary, Indian Leprosy Forum, Orissa branch, discussed the minimal amount being doled out to disabled persons in Orissa. He said Orissa is still providing a minimal of Rs 200 a month as disability pension while Goa is giving Rs. 1500, Delhi and UP Rs. 900 and Rs. 700 in MP and Kerala. He welcomed the alliance and said we can win our case only if we are united.

It has been a long journey from 1996. We are yet to have the basic mechanism in place to address our needs i.e. the Disability Commission and a full time disability commissioner. Yesterday from 21 districts more than 220 persons with disabilities, their family members, organization joined hands to demand setting up of a disability commission in Orissa. All organizations/associations and networks were represented by the heads. It was unanimously decided to present a memorandum and request you for the formation of the Disability Commission by the end of the coming assembly session. Unanimously the house agreed on the following three demands:-

1. INDEPENDENT DISABILITY COMMISSION WITH FULL TIME COMMISSIONER,
2. OFFICE OF THE COMMISSION OUTSIDE THE PREMISES OF SECRETARIAT WITH BARRIER FREE ACCESS.
3. A PERSON WITH DISABILITY/PARENT AS THE COMMISSIONER.

Sir, if the demands are not met with by the end of the coming assembly session ten lakh people with disabilities, their family members and organizations working in this sector will come on the streets to protest against the insensitivity of Orissa Government. Sir, the government is violating our HUMAN RIGHTS as per UNCRPD.

Pandab from Rourkela, Rashmi Sahoo from Rourkela, Sambit Das, Sudipta Mishra and many others from different part of Orissa opined that they all wanted the immediate formation of Disability Commission in Orissa. Unanimous voice was 'WCD dept has many role to play hence disability gets less priority. We don't want any special and unusual favor or privilege; we want to be able to attend our neighborhood school, work, and go to movies etc. We want to be treated as normal people, we are not aspiring for charity but our right.'
